State of Iowa Executive Council:

On 8-12-25, Motorola personnel discovered damage on the Brooklyn ISCS tower. It appears the site was hit by lightning due to severe storms in the area. This strike disrupted various parts of the microwave system.

Motorola Warranty Representative Dave Gordon was able to provide the DPS Interoperability Communications Bureau an estimate of \$45,000 for repairs to the tower. Repairs will commence once a tower crew becomes available.

The DPS Interoperability Communications Bureau is respectfully submitting a 29C.20 allocation request for \$45,000 regarding this act of nature damage.
