Re: Formal Loss Report - University of Iowa – School of Music Stolen Instrument (3/11/2020-3/13/2020)

Dear Executive Council,

Sometime between 3/11/2020 and 3/13/2020, a Contrabassoon musical instrument was stolen from room 24000A at Voxman Music Building, located at 93 East Burlington Street, Iowa City, Iowa.

On 11/16/2020, the Executive Council approved the University of Iowa's Formal Loss Report to purchase a replacement Contrabassoon, and a payment of \$34,795.00 was issued for the claim and received by the University of Iowa.

On 4/26/2022, the School of Music reported to University of Iowa Public Safety the stolen Contrabassoon had been returned to the School of Music and there was no damage to the stolen property. To reimburse the claim, the School of Music then sold the replacement Contrabassoon through University of Iowa Surplus. University of Iowa Surplus sold the Contrabassoon via GovDeals, see attached sale documentation.

The University of Iowa Risk Management Office is refunding the State of Iowa \$26,262.75 for the sale of the Contrabassoon.


