- CHECK YOUR STATEMENT: Be sure to pay taxes on all your properties. The Treasurer is not responsible for any taxes missed or omitted. Overpayments may not be refunded depending on your County Treasurer's refund policy. Contact the Treasurer's Office to determine the refund policy.
- TAX SALES: All delinquent taxes are published within three weeks of the Tax Sale, which is usually held on the 3rd Monday in June. Costs are added to your tax bill on May 1, per Iowa Code Chapter 446. Any unpaid tax is subject to Tax Sale. The interest rate until redemption will be 2% per month, rounded to the tearest dollar. If property is not redeemed within the time frame provided by Chapter 447, the right to redeem expires and a deed may be issued
- LOW INCOME SENIOR CITIZEN AND DISABLED CITIZEN STATE CREDITS AND MOBILE HOME STATE CREDITS: Must be:
  - 65 or older by December 1, 2023 and have a household income less than \$25,328 OR
  - Totally disabled and 18 years of age by December 31, 2023 and have a household income less than \$25,328 OR
  - 70 or older by December 1, 2023 and have a total household income less than 250% of the federal poverty level guidelines OR , 2023, and have a household income less than \$25,328, and own a Mobile/Manufactured/Modular Home.
  - · 23 or older by December 1 Property owner must file a clain vith the County Treasurer by June 1 preceding the fiscal year in which the property taxes are due. For this program. Social Security and Medicare man t be included as income. CONTACT THE TREASURER for claim forms and details.
- 5. PARTIAL PAYMENTS: The County Treasurer MAY accept partial payments. Contact the Treasurer for more information and authorization
- to make a partial payment. Partial Payments are NOT allowed on Special Assessments, Drainage Assessments, or Tax Sale Redemptions.

  RETURNED CHECKS: If you check is returned to the Treasurer, your receipt shall be void. YOU WILL BE CHARGED A FEE. If your check is returned after the tax des ilines, INTEREST WILL ALSO BE CHARGED.
- HOMESTEAD, MILITARY, DIG ABLED VETERAN AND FAMILY FARM CREDITS AND EXEMPTIONS: These credits and exemptions must be applied for at the County Assessor Office. BUSINESS PROPERTY CREDIT: Business Property Tax Credit was replaced with a 2-tier assessment limitation. All commercial, industrial and rails and properties will automatically receive property assessment limitations on the first \$150,000 per unit.
- WHERE DO YOUR TAXES ( )? The County Treasurer collects taxes on behalf of all tax authorities and distributes the amounts accordingly. The distribution of wour tax dollars is itemized on the front of this statement for your information. You may protest your VALUATION which is set by the ASSESSOR.
