Personnel Mobility Assignment Agreements (David Overton and Ryan Ortlund)

Dear Executive Council:

Iowa Workforce Development requests an inter-agency assignment of personnel as provided for in Iowa Code Chapter 28D.

The Iowa Department of Public Safety (IADPS) is looking to assign two full-time Criminal Investigators and one Intelligence Analyst to the Cooperative Disability Investigation (CDI) Program to combat Social Security Administration (SSA) disability fraud. The investigative evidence helps the State Disability Determination Services (DDS) Division make timely and accurate disability determinations. SSA and the Office of Inspector General (SSA OIG) use the evidence to determine whether other remedies (i.e., criminal prosecution and/or civil/administrative action) are warranted. The unit's work supports ensuring the integrity of the Social Security programs with zero tolerance for fraud and abuse. The IADPS will provide SSA and/or the Iowa DDS with credible and independent evidence of material fact for making disability eligibility determinations. The anticipated and proven results are cost savings and fraud prevention

Accordingly, we request Executive Council approval for an inter-agency assignment of personnel.
