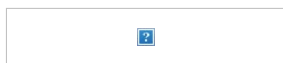

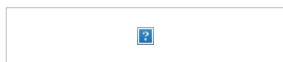

Ok, I got it figured out. We should have specified this. It will take three trips for the quarry to deliver this amount of material and its 19 miles away from the site (19 miles x 3 trips=57x10 per mile=\$570 and 60 tons of material x10.40 per ton=624 so 624+570=1194).
