State of Iowa Executive Council:

On 4-7-23, Dave Gordon, Motorola Customer Support Manager, advised that the 3-31-23 storm winds caused flying debris to break the radome cover on the **Iowa ISICS Communication Tower**. On 4-7-23, an initial 29C20 notification was sent to the Executive Council regarding this Act of Nature (AON) Damage to the Iowa ISICS tower site. On 5-8-24, Dave Gordon advised, during the recent tornadic wind event, a second radome was damaged on the Iowa ISICS Tower. On 5-10-24, the AON Initial notification regarding the second damaged radome was sent.

On 5-28-24, Motorola advised the new radome covers have arrived in the USA from the new Italian manufacturer, the new, updated estimate to repair the two damaged radomes on the Iowa ISICS Tower is \$19,000.00.

The DPS Interoperability and Communications Bureau is respectfully submitting an updated 29C20 Allocation Request for \$19,000.00 regarding this AON damage.
