In accordance with Iowa Code Section 468.57, assessments over \$500 per parcel are eligible to be paid over ten (10) equal annual installments at an interest rate of six percent (6%). A waiver for installment payments must be completed in the Cerro Gordo County Treasurer's Office.

After March 6, 2024, assessments will be charged six percent (6%) interest as provided by law, plus a \$5.00 administrative fee. Assessments unpaid by October 1, 2024 and for which applicable waivers have not been signed and returned will be charged an additional interest of one and one-half (1.5%) per month.
