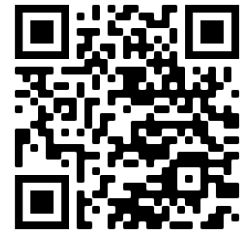

We have seen a continued influx of operating while intoxicated, driving while barred, and narcotics cases during this period. I attribute this to the Meskwaki Nation Police Officers being more aggressive with interdictions on Highway 30. Overall, the cases are strong and the officers are doing an excellent job.
