Jessica,

Thank you for the call this morning regarding your vehicle accident. I am glad that you are ok. I have attached the Tip Sheet, however, below is the portion regarding accidents and the needed steps be taken following an accident. I have also included an accident report which needs to be completed within 24 hours. Again, I am glad that you are ok and are back at home. You stated that you do plan on visiting the doctor since you shared that you are expecting. Please reach out to Reni, our HR Director, as soon as possible so that she is aware. I have highlighted her phone number below. We can get you a pool vehicle to drive whether it is one here or through DAS Fleet. Please give me a call after you get your bearings and visit with Reni.

Vehicle Accidents –

In the event of a vehicle accident, the driver will stop at once, give reasonable first aid to those injured, and will call the police. All information related to the accident and all drivers involved will be written down at the scene. Exchange information with the other driver. Once this is done, you should not have any other contact with the other parties involved or their insurance representatives. Any contacts need to be directed to Lisa Potter which will then be shared with DAS Fleet and Creative Risk.

A copy of the **Vehicle Accident Reporting Procedures and Vehicle Accident Report** form should always be in your vehicle should you not have immediate access to the internet. In most instances you should be able to go to the following link <https://das.iowa.gov/sites/default/files/fleet/pdf/AccidentReportForm.pdf> to complete the editable form and submit to DAS Fleet at DAS.Risk@iowa.gov.

This needs **to be completed within 24 hours** following the accident and if you have any questions, please reach out to Lisa @ 515-281-5713.

Immediately following an accident, notify your supervisor, along with Lisa @ 515-281-5713 or Casey if Lisa is unavailable. Notify Human Resources at 515-281-5693 immediately if you have injuries that may require medical attention so that they can direct you to the proper Workers Compensation medical professional. Should you require emergency care, please go to the nearest hospital.

After the accident report is received an estimate may also be required. This too needs to be emailed to Lisa and can be emailed from the body shop. Both will be submitted to DAS to be forwarded on to Risk (they are contracted with the State to handle vehicle damage).

The Accident Report Form and body shops can be found on the DAS Fleet Services Risk Management page. If you are at fault, Defensive Driving Classes are required.

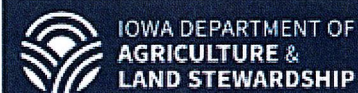

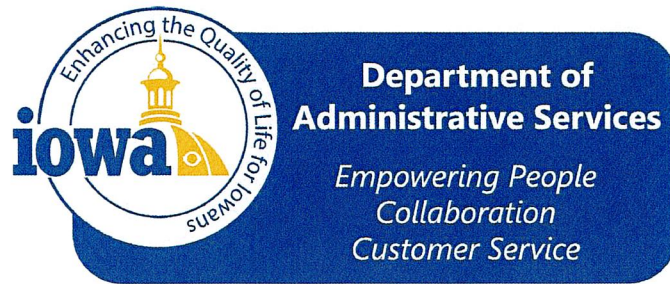

Vehicle Accident Report Form

- Render aid or assistance to the injured ([per Iowa Code 321.262](#)).
- The State of Iowa is self-insured. Refer to the insurance card and accident report procedures online or in your glove box packet. If the accident involves another party, exchange information with the driver or property owner. Do not admit fault or attempt to settle your claim.
- Call local law enforcement, if a fatality, injury or property damage has occurred, and obtain a police report. On the Capitol complex, call Iowa State Patrol, Post 16 at 515-281-5608.
- Within the first 24 hours, report accident or damage to DAS Fleet Services (515-281-3162 or DAS.Risk@iowa.gov), your agency fleet contact, and supervisor. Damage caused by an act of nature or unavoidable cause MUST be reported to DAS Fleet Services within 24 hours of the incident to qualify for contingent fund use ([per Iowa Code 29C.20](#)).
- For an estimate, locate the nearest contracted auto body repair shop in the Contracted Service Providers map. A contracted auto body shop within 30 miles should be used if available.
- If towing is necessary, contact DAS Fleet Services (515-281-3162) for assistance. After hours, call National Automobile Club (NAC) FleetRescue* (866-329-3471) or local law enforcement.
- Within 72 hours, print and submit a completed Accident Report Form, including a cost estimate from the auto body shop to DAS.Risk@iowa.gov.
- Any accident in the State of Iowa that causes death, personal injury, or total property damage of \$1,500 or more must be reported on an Iowa Accident Report Form UNLESS the accident is investigated by a law enforcement agency and a report is filed. Failure to return an accident report form within 72 hours may result in suspension of driving privileges.
