Re: Request for Special Counsel for Prosecutions on Tribal Land

Dear Victoria:

Our office requests approval to retain Michael Marquess of Marquess & Hoyer Law Office, P.C., 203 W. High St., P.O. Box 51, Toledo, IA 52342, as Special Counsel to represent the State of Iowa in prosecutions of nonnatives for crimes committed against non-natives (or without a victim) on the Meskwaki, or Sac & Fox, Indian Settlement in Tama County.

This engagement would replace that of Thomas Hillers, who expressed his wish not to renew his contract, which expires at the end of fiscal year 2023. Mr. Marquess served in this position before Mr. Hillers and has expressed the desire to do so again. He would be retained at a rate of \$6,000 per month for an initial term of one year.

A 1948 act of Congress granted the State of Iowa jurisdiction over all criminal offenses committed on the Settlement. A recent act of Congress returned to tribal authorities jurisdiction over crimes committed on the Settlement by or against natives. The State therefore retains jurisdiction to prosecute other crimes committed on the Settlement and would typically do so through the Tama County Attorney. Tama County officials have declined to do so, however, citing the Meskwaki Settlement's status as land of a separate sovereign.

The Attorney General believes crimes committed by non-natives on the Settlement should be diligently prosecuted. In the interest of public safety and equal administration of justice, it therefore requests that the Council renew its approval of the retention of Special Counsel, to be paid from the General Fund, to conduct that diligent prosecution.
