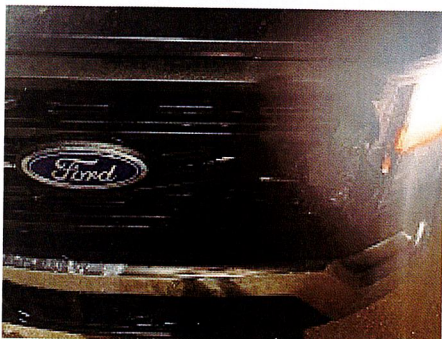

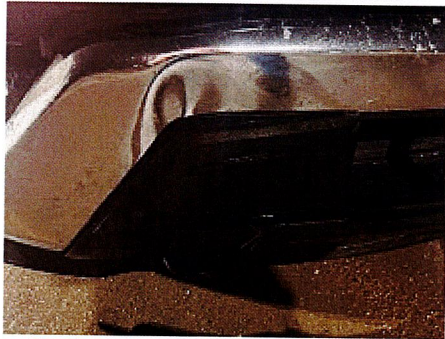

<p>On Sunday, December 15, 2024, at approximately 10:21 p.m., I, Special Agent Seth Stadtmueller, accompanied by Special Agent Evan Thompson (passenger), were both on duty status and traveling to the Carroll, Iowa area for an anticipated GPS deployment on a target vehicle. While traveling southbound on US Highway 71 towards Carroll, I encountered a group of three (3) deer emerging from the west ditch into the roadway, striking one (1) of the deer. The damage sustained to my state-issued 2023 Ford F-150 pickup truck was isolated to the front grille of the vehicle. The vehicle remained driveable, and no injuries were sustained as a result of the collision.</p> <p>I then provided swift notification to Special Agent in Charge Eric Young and requested a uniformed officer to conduct a property damage accident report through Storm Lake State Radio. Iowa State Patrol was unable to respond to take report of this collision due to no units being located in the general vicinity of the accident. I took photographs on-scene to document the damage sustained to the vehicle from the collision with the animal (deceased) crossing the roadway. Following this, a uniformed officer with the Carroll County Sheriff's Office arrived in the area and completed a MARS accident report.</p> <p>At the time of this memorandum, repairs were pending to previous damage sustained to my state-issued vehicle, and a supplemental estimate will be prepared relating to this damage by Timm's Auto Body in Webster City, Iowa.</p>
