EXECUTIVE COUNCIL OF IOWA ASSIGNMENT OF LEASE  
(IOWA DEPARTMENT OF NATURAL RESOURCES)

WHEREAS, the Executive Council of Iowa (Council), upon recommendation of the Iowa Department of Natural Resources (DNR), is authorized by Iowa Code section 461A.25, to lease public real estate in accordance with a rental fee schedule established in 571 Iowa Administrative Code, Chapter 17.

WHEREAS, on July 1, 2024, the Executive Council of the State of Iowa via resolution approved Lease 102-R, expiring on April 30, 2029, between Matteson Marine Services, Inc., a corporation organized under the laws of Iowa (Matteson), P.O. Box 667, Burlington and the State of Iowa of the following described premises:

A parcel in the bed of the Mississippi River including approximately 1600 feet of frontage by 175 feet of depth located at the vicinity of Mississippi River Mile 430.3 located in Sections 9 and 16, Township 73 North, Range 1 West of the 5th P.M., Louisa County, Iowa.

WHEREAS, Matteson has been sold to Brennan Marine Inc. (Brennan), a Wisconsin Corporation, 818 Bainbridge St., Lacrosse, WI 54603.

WHEREAS, Matteson and Brennan have requested that the State of Iowa agree to the assignment of Lease 102-R from Matteson to Brennan.

THEREFORE:


1. Matteson does hereby transfer and assign to Brennan all its rights and interest in Lease No. 102-R with the State of Iowa, dated July 1, 2024 and expiring April 30, 2029, covering the Leased Premises.
2. Brennan hereby certifies that it has been provided a copy and reviewed Lease No. 102-R, and agrees to be bound by all the terms, covenants, conditions, obligations and provisions of said Lease, a copy of which is attached hereto as Exhibit "A".
3. This assignment shall be effective as of the date of consent by the Executive Council for the State of Iowa.
4. The State of Iowa hereby consents to the assignment of Lease No. 102-R as set forth above, without waiving any rights, claims or liens under the lease and in no manner releases Matteson or Brennan from any and all of the obligations under said lease.
