50.38 - The state board of canvassers shall review the results compiled by the Secretary of State and, if the results are accurately tabulated, the state board shall approve the canvass.

50.39 - Make an abstract stating the number of ballots cast for each office, the names of all the persons voted for, for what office, the number of votes each received, and whom the state board of canvassers declares to be elected; which abstract shall be signed by the canvassers in their official capacity and as state canvassers, and have the seal of the state affixed.

50.41 – Each person declared elected by the state board of canvassers shall receive a certificate, signed by the Governor or, in the Governor's absence, by the Secretary of State, with the seal of state affixed, attested by the other canvassers...
