On behalf of the State Historical Society of Iowa, I am writing to request an allocation of 29C.20 funds for repairs related to glass damage that occurred at one of the State-owned Historic Sites, the Western Historic Trails Center in Council Bluffs.

On November 2, 2022, staff at the Western Historic Trails Center discovered damage to a glass door and a large window located at the building entrance. The damage was caused by gunfire. Staff immediately contacted the Council Bluffs Police Department and a police report was filed.

An estimate for the replacement glass has been received and **the State Historical Society of Iowa requests an emergency allocation totaling \$2519.63 for the replacement of the two damaged glass units.**

### **1.** Narrative/Overview Narrative By Paul Galus

On November 2, 2022 at approximately 0930 hours I, Ofc P GALUS #617, responded to the Western Historic Trails Center for a criminal mischief to two different windows. Upon arriving I met with Kevin HENDRIX, employee, who advised that some time between 1920 hours last night and 0900 hours today someone had shot holes into two east facing windows. One (1) window was approximately 10'x5' valued at \$2,000 and the other window (1) was approximately 2.5'x2.5' valued at \$400. Both windows were shattered and had small diameter holes.
