On 4-4-23, Dave Gordon, Motorola Customer Support Manager, advised the Aviat Tower Crew confirmed the 3-31-23 storm winds caused flying debris to break a radome cover on the Adair North ISICS Communication Tower. On 4-4-23, an initial 29C20 notification was sent to the Executive Council regarding this Act of Nature (AON) Damage to the Adair North ISICS tower site (See attached email).

On 4-18-23, Motorola provided an update to 29C20 Tracking Spreadsheet advising the repair estimate regarding the damage to the Adair North ISICS Tower is \$8,722.00. Repairs will commence when tower crews become available.

On 4-4-23, an Aviat tower crew working on the Adair North ISICS Tower discovered a damaged radome that arose after the thunderstorms on 3-31-23. This is only the preliminary damage report. It is possible there could be more extensive damage not yet discovered at other tower sites. Investigations of all potentially damaged tower sites will continue this week. Please accept this email as the required 29C20 Act of Nature Notification regarding storm damage that occurred on 3-31-23 to the Adair North ISICS tower. A repair estimate will be forthcoming upon receipt.
