On 8-14-25, Webster County EMS personnel discovered a radome was damaged on the Webster County ISICS tower. Severe storms and strong winds are believed to have caused the damage.

Motorola Warranty Representative Dave Gordon was able to provide the DPS Interoperability Communications Bureau an estimate of \$9,500 for repairs to the tower. Repairs will commence once a tower crew becomes available.
