VIII. OLD BUSINESS

A. Council to consider the purchase of an Electric Vehicle for use in the City's Police Department.

City Manager Miller-Thornton led the discussion.

On December 16, 2024, Council asked Assistant Police Chief Dunlap to provide additional information regarding electric vehicles. City Manager Miller-Thornton provided the updated information. Also, she spoke regarding the request for a F-150 Super Crew Lighting (\$68,870.00) or Electric Vehicle Interceptor.

This item was added to the Consent Agenda.

B. Council to consider the appointments to the Ethics Committee.

Councilmember Powell recommended Council to move forward with appointing members of the Ethics Committee. He asked that an alternate be picked as well.

Attorney Dreyer recommended a Caucus Meeting. He said, "there would be a reading of the people that have applied and any other names that are brought forward by members of the Council." Also, he stated, "there would be some discussion and there would be a consensus or majority vote on who the two names would be."

The four applicants are: Marcia Thomas-Williams, Lt. Chelsey Curney, Arlene Charles, and Larry Jones.

Attorney Dreyer provided clarification regarding the following:

- A person cannot serve on the DDA and the Ethics Committee.
- The Mayor can chair the meeting.
- The Mayor can appoint her applicant at any time.
- The Mayor and Council do not have to pick from the list of people that have applied.

City Manager Miller-Thornton stated, "she recalls the last conversation regarding Councilmember Powell wanting to leave the application process open-ended without having a due date.

The Caucus Meeting will be held on Monday, January 13, 2025 at 5:00 p.m. in the Council Chambers.

IX. NEW BUSINESS

A. Council to consider Annual Appointments.

City Manager Miller-Thornton led the discussion. She spoke regarding Article III, Sec. 3.10(b) Administrative and Service Departments of the City's Charter.

Based on the above Charter Section, all department directors should be appointed annually except for the following: City Manager, Chief of Police, Police Officer, Building Inspector, Code Enforcement Officer, Municipal Court Judge, Solicitor, and other officers that the city creates by ordinance (for example: the Finance Officer).

These officers are instead subject to the terms of employment agreements. Therefore, none of these positions are subject to annual appointments by the City Council and therefore have not been presented for consideration for annual appointments.

Appointments of the Public Works Director and the Community Development Director are not considered officers by charter or ordinance and therefore are directors of city departments and would come before Council annually for appointment.

The City has historically appointed the Municipal Judge annually. However, State Law provides the Judge serve two (2) year terms. A draft employment agreement has been presented to Judge Keith Wood and will be reviewed and returned by January 13, 2025. This will be in line with State Regulation.

B. Council to consider the appointment of the Mayor Pro-Tem for 2025.

City Manager Miller-Thornton led the discussion and spoke regarding City Charter Sec. 2.28. Mayor Sartor emphasized that whoever becomes the Mayor Pro-Tem would need to be available before meetings and be available via email and text messaging.

Mayor Sartor nominated Councilmember Don Dixon, but he declined the nomination.

Discussion: Mayor Sartor stated, it is not a rule or law that we rotate the appointment of Mayor Pro-Tem."

A motion was made by Mayor Sartor to nominate Councilmember Miller.

Councilmember Miller accepted the nomination.
