Customer will advise CMRA of asbestos or lead products presence, if any.

Client agrees to pay the full amount indicated in this contract estimate along with any change orders upon project completion or per draw schedule. Failure to pay the full amount shall constitute as a breach of contract. Prices will be honored for thirty (30) days from the date of the proposal. After thirty (30) days, it may be necessary to adjust the proposal due to material cost increase and or product availability. Payment may be made by cash, check or wire.
