## Race Map and Police / Sheriff Details



Race starts at 9157 Tara Blvd, Jonesboro, GA ( Green Dot ) - loops around Rick Daily Memorial Blvd. - Goes onto Tara Blvd. ( North Bound ) - Goes right onto Smith Street - Left onto Lee Street - Right onto Spring Street - Right onto North McDonough Street - Proceeds to South McDonough Street - Left at Historic Clayton County Court House - Finish at Red Dot.

The highlighted areas are made to show the broad area that each group of requested officers / deputies are needed on or around Tara Blvd. as a part of the race route. The following pages show more detailed views of the area and give more details of officers / deputies needed in each area.



The following images and art work are purely for visual reference and are not meant to be used at guidelines for Sheriffs Office Deputies or Police Officers to station themselves on the race route in any exact position based on the images and art work shown below.

Area 1

Deputy Rick Daily Memorial Blvd



Two deputies are needed along Deputy Rick Daily Memorial Blvd

## Area 2

### Fayetteville Rd / Court House Stretch



Three or Four deputies are needed along Tara Blvd. between the end of Deputy Rick Daily Memorial Blvd. and the Fayetteville Rd. & Tara Blvd. intersection.

### Tara Blvd & Fayetteville Rd

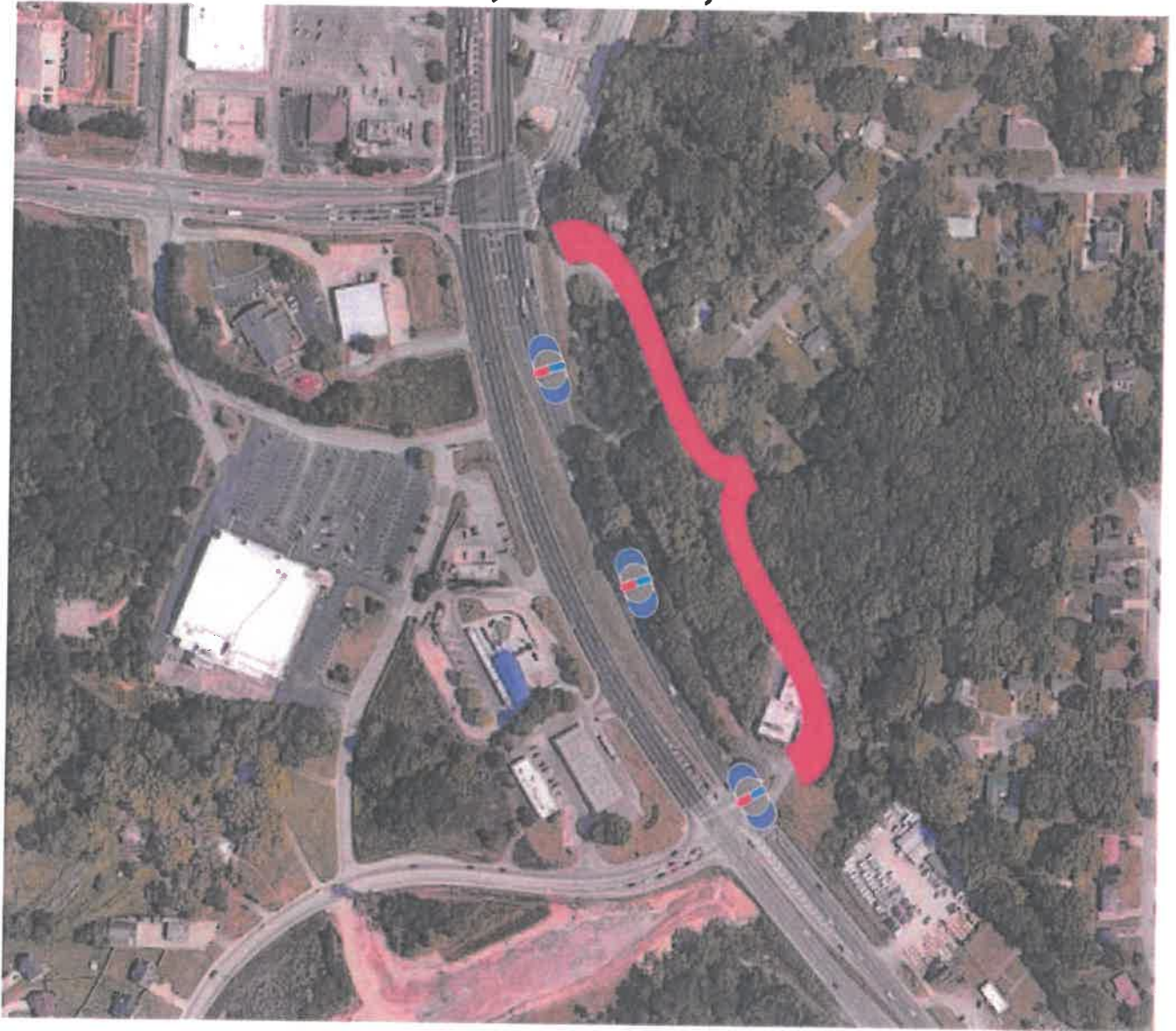


Two deputies are needed at the Tara Blvd. & Fayetteville Rd. (Hwy 54 ) intersection

## Flint River & Fayetteville / Hwy 54



Three deputies are needed between Fayetteville Rd. ( Hwy 54 ) and the Flint River Rd. / Fayetteville Rd. & Tara Blvd. intersection

#### Area 4

#### Flint River Rd. / Robert E. Lee stretch

Three deputies are needed between Flint River Rd. and Robert E. Lee Rd.  
Additionally, 2 deputies are needed at Robert E. Lee & Tara Blvd. intersection - and lane 3 ( Outside lane ) needs to be blocked for runners



#### Tara Blvd & Robert E. Lee / Smith St.
