## **VII. NEW BUSINESS**

- A. Discussion regarding Alcohol Beverage Pouring License Application #25-ALC-001 to dispense beer, wine & distilled spirits at 265 Jonesboro Road, Jonesboro, Georgia 30236. The legal business name is Ray's Place Where Chicago Meets Atlanta. Kelly J. Epps has requested to be the License Representative. *(Required hearing and consideration set for Monday, February 10, 2025.)*

City Manager Miller-Thornton led the discussion.

- B. Council to consider a Proposed Compensation Plan/Incentives for Jonesboro Police Department.

City Manager Miller-Thornton led the discussion regarding the Recruitment and Retention Plan (Part A) that was put together by Chief Coyt. She spoke regarding a proposed \$7,500.00 Sign-on Bonus for each of the nine (9) positions remaining vacant. The nine (9) positions x \$7,500.00 = \$67,500.00 (employer taxes must be considered). The money would be taxable at \$72,664.00 as the total.

Option 1 – Half of the payment would be due and payable at six (6) months and the other half would be payable at the conclusion of one (1) year of employment with the City.

Mayor Sartor clarified that the Recruitment Bonus is paid out in its entirety at \$500.00 on day 91. Mayor Pro-Tem Messick asked City Manager Miller-Thornton to get benefit information from other surrounding cities. Mayor Sartor asked City Manager to obtain information from the County as well.

The Council agreed to do \$1,000.00 recruitment bonus (\$500.00 in 90 days and another \$500.00 in 90 more days). The employee(s) would have their total by the 181<sup>st</sup> day. This would be for any employee that does a direct referral to the Police Department.

- C. Council to consider a Proposed Revised Fee Schedule for use of the Jonesboro City Center Community Room.

**The item was added to the Consent Agenda.**

- D. Council to consider adoption and approval of Ordinance 2025-002 regarding An Ordinance Amending the Jonesboro Personnel Policies and Procedures, Chapter VIII, Section D - Hours of Work.
