Good afternoon,

Back in October, DDA board & staff applied for a “Footsteps through Time” grant from the Ga Council for the Arts. They reached out earlier this month, asking if we were still doing the grant. (They haven’t had any communication or response since October.) The GCA has extended the window to submit documents and for us to complete the project by the end of May.

I’ve been talking with Arts Clayton, and they can help us with the project. What I need from the DDA Board to complete:

- Approval to sign & submit the grant application
- Approve the payment to Arts Clayton for \$5k. (When they bill us) The GCA will reimburse us for the expense upon completion and report out.
- Approval to modify the grant from “Footsteps through Time” to “Pictures through Time.” This is based off feedback from Arts Clayton; they feel footsteps will be too small to contain the visuals, and suggested changing it to a Polaroid-type picture frame. I am sure Arts Clayton will provide a draft/sketch/demo of the art before it goes up.

Below is the email from the Ga Arts Council. I’ll work on the documents as y’all discuss and let me know.
