Director Heard led the discussion and recommended Scopes Landscape.

- C. Council to discuss 2026 Housing Commitments (Housing Leadership Academy, Atlanta Regional Commission).

Council received a copy of the 2026 Housing Commitments. Mayor Sartor shared that as a member of the Housing Leadership Authority Academy with the Atlanta Regional Commission, "we were tasked as a completion of the program to come up with some housing commitments." Statements and feedback from Council would be shared in the ARC's Housing Commitment Publication.

The first one is up under preserve affordable housing supply by addressing blight. The City would do this by revising existing code to include updated state ordinances related to blighted properties of which we've already received the initial training on that, and we'll be moving forward and also explore additional home repairs from DCA similar to what we did with our CDBG funding.

The second area would be to allow and incentivize innovative housing types. The City would do this by expediting our permitting and considering waiving fees for affordable housing. Also consider repurposing buildings that are existing and may not be zoned for housing into affordable housing.

Lastly, is to support local leaders through regional programs similar to Housing Leadership Academy. I would ask that one council member apply for the 2026 Housing Leadership Academy. Also designate one staff member to focus on housing whether or not we would

consider a stipend or add it to our economic development position and encourage all elected officials to attend at least two ARC housing task force meetings per year. And all of those meetings are via Zoom. No vote is required...just had to be read into the record.

D. Discussion regarding new information received from Attorney Friduss as it relates to the investigation.

At this time, Mayor Sartor read the attached statement into the record.

Mayor Sartor asked Council if they wanted to entertain a motion to permanently halt the investigation by Attorney Friduss. No one responded.

Councilmember A. Dixon asked if the investigation was already halted. Mayor Sartor said that Attorney Friduss halted it, but the Council has not. Mayor Pro-Tem Messick stated the attorney reached out to let them know there needed to be corrections. The Ordinance needed to be modified or the Letter of Engagement because there are discrepancies. She proposed that Attorney Dreyer reach out to Attorney Friduss to modify the Engagement Letter so that it would match the Ordinance that the Council passed. Therefore, it would be narrowing the scope of what he would be looking into.

Mayor Sartor said the Ordinance is referencing Financials and a CPA can do that. Mayor Sartor and Mayor Pro-Tem Messick had a back-and-forth conversation defining "Administrative Investigation." Administrative Investigation is what we named it in the Charter.

Mayor Sartor read a section of Ordinance 2025-008. "This investigation shall conduct an administrative investigation into all financial transactions occurring from, to and between the City of Jonesboro and the City of Jonesboro Downtown Development Authority for fiscal year 2025.

Mayor Sartor stated that the administrative investigation is to financials. She further stated that administrative is the type of investigation. "What are they investigating?" "Financial Transactions." She said why not call a CPA instead. The attorney has no background for auditing finances. The City already has a forensic audit and why not just attached this matter to it. She mentioned Mayor Pro-Tem having a previous relationship with the attorney.

Mayor Pro-Tem Messick said for the record, "she is not a friend of Attorney Friduss."

Mayor Sartor stated that the attorney is not fit nor qualified to do a financial analysis.

At 6:42 p.m. Councilmember Miller entered the meeting.

Councilmember Miller asked if it was factual that more money or more than \$50,000.00 was spent on Juneteenth or between Juneteenth and the DDA? Mayor Sartor said the bulk of the spending was related to Downtown other than just regular expenses. She said Maria could help answer this question. Maria said there were maybe 7-8 transactions.

Maria mentioned there were some wires transferred from the City to the DDA. The Firework money was put back into the DDA account from the City. Councilmember Miller concluded that there are processes that were not followed and should be cleaned up. However, there was no wrongdoing, no harm, no foul.

For the record Mayor Sartor proposed that Council do not use Attorney Friduss because he is not a CPA. Mayor Sartor said there are about eight (8) transactions and the City needs to save money.

Mayor Pro-Tem Messick said, "you have to look at the bigger picture and practices so that the mishandling of money is not continued." Mayor Sartor said in order to save money, Council and staff could look at the transactions and narrow the scope instead of paying someone from outside to do that. Mayor Sartor said this is very discriminatory because no one questioned St. Patrick's Day, the Ice Cream Social, Spring Fling, etc. Again, she stated for the record that she

does not propose Council to use Attorney Friduss because he is not qualified to do a financial audit.

Mayor Sartor asked Council if they wanted to entertain a motion for a recess. No one responded.

Motion to ask City Attorney Dreyer to contact Attorney Friduss and have the Letter of Engagement modified to be more in line with the ordinance that dictates its existence.

Councilmember Miller asked if a cap could be placed on the investigation.

Mayor Sartor said for the record, cities can own property and are allowed to own properties.

Mayor Sartor said once Maria finds the number of transactions, an ordinance should be prepared that clearly outlines the number of transactions...he needs a clear scope. She wants Attorney Dreyer to be very specific and clear to the scope when speaking with Attorney Friduss.

Mayor Sartor stated that “an ordinance cannot be prepared tonight because no vote can be taken tonight because this was an item added to the agenda and I am not in the majority. I'm not in the unanimous vote for it to be voted on tonight.” Again, she restated, “This item was added to the agenda. Items can be added to the agenda by majority vote, but items can only be voted on by unanimous vote. I do not consent to voting for this particular item.”

Point of Personal Privilege by Mayor Pro-Tem Messick – With us trying to cooperating ...statement not completed.

- E. Council to consider approval of a renewal contract between Luminary MediaWorks and the City of Jonesboro, Georgia for IT Servies.

Mayor Sartor shared that Mr. Tran will add a subsequent contract. It would run separate and the City will allocate a certain amount of funding along with giving a rate to make sure up to 10 meetings per the year would be live streamed. The City would cover it and would need to ensure that they are not doing 50 hours of live streaming.

Councilmember A. Dixon said thank you so much.

XIII. NEW BUSINESS

- A. Council to consider a resolution regarding a budget transfer of \$8,000.00 from Office Supplies line item 100-1500-53-1110 to Special Events line item 100-1500-53-1110 in order to cover the cost of Christmas Events at the City Center.

Mayor Sartor shared the City would like to provide a \$100.00 bonus to all full-time staff and \$50.00 bonus to all part-time and reserve officers. The City's traditional Christmas event to be included.
