APPLY

Residents submit a completed application along with:

- ✓ Driver's License or State ID
- ✓ Utility Bill or Lease Agreement

2



VERIFY ELIGIBILITY

City staff verifies:

- Jonesboro residency
- Complete application
- Required documentation attached

Only eligible applications move forward.

REVIEW

A review committee confirms each application meets the program requirements by considering:

- Household safety concern
- Requested safety device
- Applicant's statement of need

The committee verifies eligibility only—it does not rank applicants or assign preference based on age, disability, income, race, or any other protected characteristic.

SELECTION

- If the number of eligible applications is equal to or less than the available devices, all eligible applicants will receive assistance.
- If the number of eligible applications exceeds the available devices, recipients will be selected through a **public random drawing** conducted by the City to ensure a fair, transparent, and impartial process.

NOTIFICATION & DISTRIBUTION

- Selected applicants will be notified by phone and/or email.
- Applicants will verify their identity at pickup.
- Recipients will receive their safety device and educational materials.



SELECTION NOTICE

Submission of an application does not guarantee receipt of a safety device. The City of Jonesboro is committed to administering this program fairly and without discrimination. If demand exceeds available resources, a public random drawing will be used to select recipients from all eligible applicants.
