Mayor Sartor led the discussion regarding the need for Intergovernmental Agreements between the City of Jonesboro and Downtown Development Authority concerning partnership and as it relates to finances.

- E. Council to consider separation of Downtown Development Authority/Main Street.

A discussion took place regarding the structure of DDA/Main Street. It was noted that the DDA cannot independently determine its structure; only the City Council has that authority. Per City Attorney Dreyer, the DDA may set its own Bylaws, but the geographic boundaries and structural decisions must be made by Council.

Another discussion took place on whether the City should be paying for the utilities of Nouveau or if DDA should be paying for it. Mayor Sartor asked Council if they agree with paying the utilities. The City is not sure how the City started paying Nouveau's utilities. She emphasized the importance of establishing Intergovernmental Agreement (IGA's) to clearly define responsibilities and financial arrangements between the City and the DDA. She said if there is a financial interest between the two then there needs to be an IGA. For example: the utilities being paid for the property, City Green (In-Kind Service), attorney fees, Executive Director position, etc.

Mayor Pro-Tem Messick requested to table the item until more information is received. No further action was taken.

Mayor Sartor spoke regarding the map in regard to a member of the DDA. She made a request to accept the resignation of that specific board member. The geographic area can only be changed by way of Resolution. Councilmember Miller asked if the person resigning has a business in the area. Mayor Sartor said no. Applications are coming in and will come before Council in November.

City Attorney Dreyer said it is his opinion that anyone who does not reside in the geographic map or own a business in the geographic map is not eligible to serve.

Lastly, Mayor Sartor spoke regarding the audit and being out of compliance per the DCA; Expecting a site visit for the City's 2023 audit during the first two weeks in November. "She said in regard to changes to the DDA, the CPA that is doing our forensic audit will continue (for the record) doing the audit for the DDA so that we are in compliance as stated by our current Charter." The City cannot close out the audit without theirs."

Mayor Sartor spoke about the DDA Executive Director position and meetings.
