- I. CALL TO ORDER** – Meeting called to order by Tammary at 6:04pm.
- II. ROLL CALL** – Santia Fox, Trina Kolawole, Helen Meadows, Donya Sartor, Tammary Scott, Jule Segner.
- III. ADOPTION OF AGENDA** – Santia motioned to accept the agenda and Helen seconded. The vote was unanimous.
- IV. FINANCIAL STATEMENTS** – Andrew discussed the financial statements. We are still holding around \$160,000 which is meant to be paying off the bond on Broad Street. Andrew is still waiting for clarification in writing by finance in what to do next. Provisionally a 3 year pay back had been discussed but nothing had been received or a Memorandum of Understanding saying that. Andrew will also be looking at another CD to gain interest this year.
  - A. Board Members to consider approval of the Financial Statements for 31-day period ending December 31, 2024.** Andrew discussed the financial statements. We are still holding around \$160,000 which is meant to be paying off the bond on Broad Street. Andrew is still waiting for clarification in writing by finance in what to do next. Provisionally a 3 year pay back had been discussed but nothing had been received or a Memorandum of Understanding saying that. Andrew arranged with Truist to have a high-rate interest CD.
