FLY OVER CONTRACT

This agreement between The City of Jonesboro, Georgia (hereinafter known as “Organizer”) and Full Throttle Airshows Corporation, (hereinafter known as “Team”), agree to the following commercial and delivery terms for the Juneteenth Freedom Festival (hereinafter known as “Organizer Event”).

1.0 Background:

The Full Throttle Airshows Corporation is a Georgia Non-Profit Corporation dedicated to entertain, inspire and educate the public on aviation and science. The Team offers its volunteers, their aircraft, and services to the Organizer so that the Organizer may provide them for their customers to enjoy.

2.0 Date(s) and Contact Info:

3.0 The Organizer and the Team agree to the following:

- The Organizer will pay Full Throttle Airshows the performance fee of \$ 3000 for the fly-over performance(s).
- A travel fee may be calculated based on the venue’s round-trip distance from Peachtree City, GA (airport identifier, KFFC). The round-trip distance will be charged at the rate of \$3.50 per NM for the travel of the entire Team. (See “Travel Fee” below).
 - Round-trip distance from KFFC (NM): N/A Travel Fee: Waived

4.0 Full Throttle Airshows will provide the following:

- Team airshow aircraft for flyover event(s).
- A Team Member will be available the week prior to the airshow for interviews via telephone or other electronic medium. For media information requests, the Team provides its website at www.FullThrottleAirshows.com as a source of content about our pilots, aircraft, and activities.

- c. A Team Liaison will provide a single point of contact and interface between the Organizer and the Team.
- d. The Team will have in force, for the fly-over, by each individual pilot and plane a One-Million Dollar (\$1,000,000) liability insurance policy on all airshow aircraft.
- e. At Organizer's request, the Team will provide a "Ground Coordinator" and a means to communicate in "real-time" with the event stage manager to coordinate fly-over timing (mobile radio, cell phone, etc.)

5.0 Organizer will provide the following:

- a. The Organizer will include "Full Throttle Formation Team" in all advertising for the Organizer Event. This includes marketing material, newspaper articles, announcements, social media, and web sites. For social media the Organizer will include hyperlink tags in all stories, posts, and reels regarding the Organizer Event.
- b. Access to the event site for the "Ground Coordinator" and a means to communicate in "real-time" with the event stage manager to coordinate flyover timing (mobile radio, cell phone, intercom, etc.)
- c. For events within 200 NM round trip distance from KFFC no other Organizer provisions are required.

X For events beyond 200 NM round trip distance from KFFC and/or multiple-day events, the Team requires an operating location near the event site to pre-position aircraft and pilots. In this case, the Organizer will provide the following:

- 1. One non-smoking hotel room for each pilot for each overnight.
- 2. A minimum of two (2) vehicles, insured and fueled, with capacity to accommodate the team will be made available on the Team's arrival at the Organizer Event.
- 3. A liaison to interface with the Team to provide logistical support.

6.0 Terms and Modification:

- a. A twenty-five percent (25%) deposit is due upon contract signing. This deposit is refundable to the Organizer if The Team is unable, for any reason except weather, to arrive at the Organizer Event.
- b. The final amount of the fee is due and payable on the final morning of the Organizer Event.
- c. Meteorological conditions must be suitable for the performance as determined by the applicable Federal Aviation Regulations (FARs). Winds at KFFC or the operating airport may not exceed 25 knots (from any direction) or a 15-knot crosswind component on the most favorable landing runway. If the Team does not position at KFFC due to weather, the deposit is refundable. In the event the Team positions at KFFC with the intent to perform the Organizer Event or launches from KFFC but is unable to arrive at the operating airport or Organizer Event due to weather, the Team retains the deposit, and no further fees are due from the Organizer. Once The Team is positioned at the operating airport for the Organizer Event, the Organizer is responsible for the total fee. If due, any deposit and/or remaining fee will be refunded within fifteen (15) days of the Organizer Event date.
- d. Licenses, Taxes, and Fees: The process quoted does not include any applicable federal, state, or local taxes and fees. The event Organizer agrees to provide all necessary federal, state, and/or local

licenses and fees for the conduct of this event to include all necessary copyright fees, licenses, and charges.

9.0 Insurance and limitation of liability:

ORGANIZER ACKNOWLEDGES AND AGREES THAT IN NO EVENT SHALL THE TEAM, ITS LICENSORS, ANY AFFILIATE OR ANY OFFICERS, DIRECTORS, EMPLOYEES, SHAREHOLDERS OR ANY THIRD PARTY BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGE OR LOSS OF ANY NATURE, INCLUDING, BUT NOT LIMITED TO, DAMAGES RESULTING FROM DELAY, LOSS OF PROFITS, INJURY TO PERSON OR LOSS OF GOODWILL WHICH MAY ARISE IN CONNECTION WITH THE GOODS AND SERVICES PROVIDED.

10.0 Confidentiality:

Both the Organizer and the Team agree to hold in confidence the terms and conditions set forth in this agreement.

11.0 Governing Law:

This Agreement shall be governed, construed, and interpreted in accordance with the laws of the state of Georgia. Organizer hereby consents and submits to the exclusive jurisdiction and venue over any action, suit, or other legal proceeding that may arise out of, or in connection with, this Agreement, by any state court located within Fayette County in the State of Georgia, or the U.S. District Court, North District of Georgia.

12.0 Force Majeure:

Neither party shall be in default by reason of any failure of performance of this Agreement if such failure arises, directly or indirectly, out of causes reasonably beyond the control or foreseeability of such party.
