Cancellations: **If the event is canceled, the deposit will be forfeited.** If the event is rescheduled and a new date and time are set that both parties mutually agree upon, in writing, the deposit will be applied to the new date.

Events that cancel less than 60 days before the event date must pay the balance in full within 30 days unless the event is rescheduled within 14 days.

In the unlikely event that representatives of Team M3M are unable to appear on the agreed upon date and we have to reschedule the date for Bishop William Murphy and/or Team M3M, we will work with the host to reschedule a new date within 14 days, and the deposit will be applied to the new date.

Recording: All requests for audio/video recordings for any other purpose than archival, unfortunately, must be denied, as the music, and the lessons, are now the shared intellectual properties of Bishop Murphy, his label, and his publisher. Before leaving the venue, Bishop Murphy must be given a copy of all recordings.
