If your Cisco Flex license isn't renewed, the system will initially enter an "out-of-compliance" or evaluation mode for 90 days starting on July 1, 2025 allowing you to renew, after which it will move to an "enforcement" state with limited functionality (no changes can be made) and no support will be provided by either Cisco or NetPlanner.
