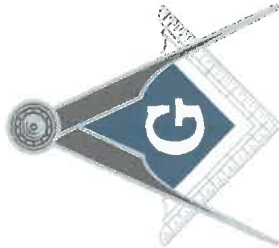

- CABINET:** 2" ALUMINUM ANGLE INTERIOR FRAME CLAD WITH .063" AND 1 1/2" ALUMINUM ANGLE RETAINER TRIM PAINTED P1.
- CABINET FACE:** 3/16" WHITE ACRYLIC FACE WITH DIGITALLY PRINTED VINYL GRAPHIC (D1).
- ILLUMINATION:** PRONTO TRACK FOR FOUR LINES OF 6" LETTERS. INCLUDES NEW SET OF LETTERS. INTERNALLY ILLUMINATED WITH WHITE LED MODULES. 12V POWER SUPPLIES LOCATED INSIDE CABINETS. WIRING OUT TO EXISTING POWER SOURCE.
- INSTALLATION:** CABINET TO BE PLATE MOUNTED TO EXISTING STEEL POLE. **ADDITIONAL FIELD SURVEY REQUIRED PRIOR TO PRODUCTION TO DETERMINE MOUNTING DETAILS.**
