VIII. PUBLIC COMMENTS (PLEASE LIMIT COMMENTS TO THREE (3) MINUTES)

- Lance Van Dike (Jonesboro, GA) – Spoke regarding increase in taxes, but not getting what he pay for such as events. Own businesses in the City. Code Enforcement citing business owners because they are no longer zoned. Address is 251 S. Main Street, Jonesboro, GA. Mayor Sartor told him that the change is for new and incoming businesses. Old businesses were grandfathered in. Mayor said if people pay additional taxes they should see the impact.
- David Hembrick (Riverdale, GA)– Clayton County District #3/National Riffle Association – Spoke about election season, accountability, transparency, honesty. He said “it seems after election, these things go away.” People are afraid of an audit. Said he was a member of the NRA (National Rifle Association) and they have audits every year. Also, spoke regarding tax audits, accountability, and the Ethics Board.

XII. OLD BUSINESS

- A. Council to consider approval of the proposed revisions made to Jonesboro Youth City Government Charter (Article II, Sec. 33-2), to ensure consistency throughout the document.

Mayor Sartor shared her concern regarding four (4) members constituting a quorum. She said she thinks it requires five (5).

RESULT: Tabled (Vote was unanimous)

The above motion was withdrawn (see page 5).

Councilmember A. Dixon stated “in the past it took five (5) members to make a quorum, but now I would like the language to read (4) members. Also, he recommended the language Jonesboro Youth Council be changed to Jonesboro Youth City Government.

The only people that would constitute a quorum for JYCG, would include the Mayor and six (6) Councilmembers.

B. Council to discuss FY 26 Budget.

Mayor Sartor shared the changes that were made to the budget as of 8/7/25. She mentioned that she had removed the special initiative. Councilmember Miller said she does not agree with the cut to the Initiative Funds.

Travel – Recommendation made to cut in half (just in case any new council want to attend new members training)

Discussion Regarding The Budget And Financial Report:

At this time, Finance Director Cannady provided a financial report.

Mayor Pro-Tem Messick inquired about Georgia 1 Fund. Mayor Sartor said there is \$2.7 million in this fund.

Finance Director Cannady provided the account balance as of June 30, 2025. General Fund 731. Also, she spoke about a CPA firm name Tab & Tab, LLC that is located in downtown Atlanta, Georgia. She said they are ready to start the audit for FY 2023 and hopefully it can be completed by the end of the year and then they can jump into FY 2024. She will obtain a quote by the end of the week for Council’s review. Mayor Sartor said an RFP is not required since it is a professional service.

The proposed budget for this service is \$45,000.00. Mayor Pro-Tem Messick said she would like a quote. Mayor Sartor said this is a 12-month plan to get the City caught up with all of the audits.

A motion was made for Council to consider approval to move forward with Professional Services by an audit firm selected by Finance Director Cannady and Ed Wall, not to exceed \$45,000.00 and to begin immediately.

- B. Council to discuss proposed street closure submitted by Bo Durban for The Trans Am Takeover - Georgia on October 17-19, 2025. This is a three (3) day celebration of Smokey and the Bandit, highlighting Jonesboro's role in the iconic 1977 film. The road closure would include Broad Street and South Main Street (from the Lawyers' Office at 102 S. Main Street to Arts Clayton, 136 S. Main Street, Jonesboro, Georgia.)

- C. Council to discuss Health Benefits

The proposed FY 26 Budget reflects a possible 10% increase. This is what the market is trending. The City pays 100% of employees' health benefits. However, there were concerns that the City was paying a portion of employee spouse policies, employee children's policies, and family policies. Mayor Sartor shared with Council a document that showed those individuals who are using the employee children and employee spouse benefits. No one is using employee family benefits. She asked Council if there was a certain percentage that the City wants to pay for employee spouse, employee children, and employee family. At this time, there are 33 individuals covered in the policy and nine (9) staff that use the policy, other than employees only. Mayor Sartor said she will bring this item back for a vote in September but wanted to have this discussion.

In the past, there was a discussion regarding the City contributing 50% for employee spouse, employee children, and employee family rather than completely removing it because it would have a significant financial impact on the employees that have to utilize it.

Example: Current premium for employee + child(ren) = \$1,366.32. The City pays \$1,249.00 (79%) of the premium and the employee pays \$116.00 (20%).

Example: Current premium for employee only is \$0.00.

Example: Employee + Spouse with no children = \$142.00 (28%) paid by the employee. The City is covering 71%.

Mayor Sartor proposed the City do not require employees to completely pay for it, but reduce the City's share from 71%-79% to 50% effective January 2026. The City only has one policy - Cigna.

Councilmember Miller recommended keeping everything the same until the City can figure out a budget that allows us to give the employees more than a 2% raise, especially if we are going to ask employees to pay additional money towards their premiums. Healthcare is very important.

A motion was made to continue with the same percentage of coverage that the City is currently providing.

D. Council to discuss Forensic Audit re. Plante Moran.

A discussion took place regarding the scope of work and how much it would cost. Mayor Sartor said they need to have the contract in front of them for review and discussion along with clarifying the allegations. Mayor Pro-Tem Messick spoke about diving deeper into the health benefits. Attorney Ngubeni recommended waiting for Attorney Dreyer to return to discuss the matter in detail. Mayor and Council agreed.

A motion was made for council to consider approval to table the discussion until City Attorney Dreyer is present to speak on the above-mentioned matter.

RESULT: Approved to table (Vote was unanimous)
