III. OLD BUSINESS

A. Council to discuss FY 2026 Budget.

Mayor Sartor's Budget Presentation.

What is a Millage Rate?

The amount of tax charged per \$1,000 of assessed property value. For example:
1 mill = \$1.00 collected; 2 mills = \$2.00 collected; and 8.5 mill = \$8.50 collected
10 mills - you pay \$10.00 in tax for every \$1,000.00 of taxable value.

What is a Roll Back Rate?

A rollback on a millage rate is a tax adjustment tool used by local governments to prevent automatic tax increases when property values rise due to reassessment. When property values go up, keeping the same millage rate would result in higher tax revenue. A rollback

rate is the lower millage rate that would generate the same total revenue as the previous year – excluding new growth. It's essentially a way to neutralize the effect of reassessments.

The City is required by law to post a 5-year levy.

Mayor Sartor explained her reasoning for proposing an increase from 8.5 mills to 11.5 mills. She spoke about capital projects and debt services for the Capital Project. Ed Wall said the City should be at 12.5 mills in order to cover debt services. Mayor Sartor built a proposed budget at 11 mills based on staff needs. She stated the City received a \$5 million grant for two (2) projects. "The City applied for three (3) grants, and we received them."

Mayor Sartor asked the audience if they had any questions:

- Speaker's Name Unknown:
Tipper Truck – Will the City obtain a loan or pay it with cash? A gentleman recommended the Environmental Fund of Georgia.

Cash in the account. Annual yield on funds.

New Market Tax Credit to refinance the building.
- Karrie Thompson - Spoke regarding Sanitation and Code Enforcement - Trash that is left in residents' driveways or on the road (N. Lake Drive).

Mayor Sartor told residents that she has an open-door policy and all they have to do is contact Shelby, her Executive Assistant. The Mayor said she would check out N. Lake Drive.
- Speaker's Name Unknown - Asked who is the auditor for the City. The Mayor shared that the City does not have one at this time.
- Robin Hall - Asked why all of these projects were done in the City.
- Russell Smith - Asked if there was a contingent plan if the budget is not passed by the deadline.
- Santia Fox - Asked if not having a fund affects us.

Mayor Sartor asked Councilmember Powell what Council's plan was to pay off the City Center building. He replied with bonds, taxes, and SPLOST.
