AGENDA ITEM DESCRIPTION:

Enclosed for your review and consideration is a request to award the aquatic center feasibility study to OLC Architecture, Interiors & Aquatics.

The Town has recently acquired two properties, one that was formerly the location of Letford Elementary School and one that is located southeast of Town Hall that need to be master planned. As part of the consideration for those properties, in 2022, residents requested that the Town consider pursuing the construction of an aquatics center. On January 8, 2023, the Town issued a Request for Proposal (RFP) to complete a feasibility study for an outdoor aquatics center for Johnstown. The final plan will include a full site analysis with all estimated costs, including design, constructing, permitting, soft costs, parking requirements, long-term operation and maintenance costs and projected revenues for 20 years.

The Town received four bids on the project as summarized below:

Ranking	Consultant	Bid Price	Reimbursables	Total Price
1	OLC Architects, Interiors & Aquatics	\$74,980	\$4,000	\$78,980
2	Sports Facilities Companies	\$55,360	Not specifically stated	>\$55,360
3	Hotel & Leisure Advisors	\$75,000	\$11,000	\$86,000
4	Architect One	\$79,500	\$0	\$79,500

Town Staff reviewed the four bids using criteria outlined in the RFP. The criteria included the following:

- Previous experience in similar projects/references included
- Expertise of key personnel and/or team partners for identified roles
- Project understanding and proposed strategy for success
- Approach to project management and delivery
- Cost & Schedule

After careful deliberation and review, Staff recommends awarding the bid to OLC Architecture, Interiors & Aquatics based on their approach and extensive experience. The total cost of the project is \$78,980.

This item was postponed from the March 20, 2023 meeting.

LEGAL ADVICE:

The Town Attorney has reviewed and accepted the language in the Town’s Professional Services Agreement to be utilized for contract execution.

FINANCIAL ADVICE:

In Fiscal Year 2023, the Town budgeted \$250,000 for master planning in the Parks and Open Space Fund.

RECOMMENDED ACTION: Staff recommends awarding the Aquatic Center Feasibility Study to OLC Architecture, Interiors and Aquatics.
