AGENDA ITEM DESCRIPTION:

In conjunction with a Petition for Annexation for the Archdiocese Annexation Nos 1 and 2, the Town has received a request to establish zoning for the property. The property is west of Weld County Road 19, and north of Weld County Road 44, adjacent to and encompassing portions of the Little Thompson/Hillsborough reservoir (Attachment 2).

The western portion of this property is known as Archdiocese Annexation No. 1, and would establish H-A (Holding Ag) zoning; the eastern portion, known as Archdiocese Annexation No. 2 would establish the PUD-MU (Mixed-Use) zoning (Attachment 3). A separate Outline Development Plan is being proposed to further define the PUD zoning on this property.

The Planning & Zoning Commission (PZC) held a public hearing on February 15, 2023, to consider the zoning for Archdiocese Annexation Nos. 1 and 2 (Case ANX22-0003). The Planning & Zoning Commission Agenda Memorandum for the annexation and zoning (Attachment 5) provides background and historical use of the property. The property has been undeveloped agricultural land within unincorporated Weld County, with some limited oil and gas facilities.
