AGENDA ITEM DESCRIPTION:

The Town has received an application for consideration of the Dove Solar Outline Development Plan (ODP) encompassing approximately 46.6 acres of land known as the Archdiocese Annexation Nos. 1-3 (47.49 Acres total, including CR 19 right-of-way). The property is west of Weld County Road 19, and north of Weld County Road 44, adjacent to and excluding of the Little Thompson/Hillsborough reservoir (Attachment 2).

The proposed Outline Development Plan shows the intent to develop an interim use for a community solar facility, proposed as a Use by Special Review, on about 31 acres of the eastern half of the site with farming and ag operations continuing on the remaining portions, until future development occurs. (Attachment 4)

The Planning & Zoning Commission (PZC) held a public hearing on February 15, 2023, to consider the annexation, zoning, ODP, and the USR. The Planning & Zoning Commission Agenda Memorandum (Attachment 4) provides background and historical use of the property.

Based upon the materials submitted, analysis, and findings, the PZC recommends approval of the Dove Solar Outline Development Plan to the Town Council.
