AGENDA ITEM DESCRIPTION:

Enclosed for your review and consideration is a request to award the professional auditing services to Hinkle & Company, P.C.

The Town recently issued an RFP seeking proposals from qualified certified public accounting firms to provide financial audit services for the year ending December 31, 2024, with the option, on mutual agreement of auditing its financial statements for each of the four (4) subsequent fiscal years. Renewals will be automatic unless either party terminates the agreement prior to October 1st of each subsequent fiscal year by giving the other party written notice.

The Town received four proposals on the project as summarized below:

Town Staff and Town Council reviewed the four bids using the criteria outlined in the RFP. The criteria included the following:

The Community that Cares

- 1. Scope of Proposal
- 2. Firm Capability and Reputation
- 3. Cost
- 4. Schedule

Independent scoring and evaluation by both Council and Staff favored a selection of Hinkle & Company for an award based on aggregate totals. After this review and evaluation, staff recommends awarding the bid to Hinkle & Company, based on their approach and extensive experience. The cost for the audit in 2024 is expected to be \$28,500.
