ORDER FOR PAYMENT

On approval of the Amendment of Oil and Gas Lease associated herewith and on approval of
title to same, PDC Energy, Inc., will make payment as indicated herein, by check, within 45
business days of receipt of the original fully executed Order of Payment and the Agreement
(Amendment of Oil and Gas Lease). Payment is deemed complete upon mailing or dispatch. No
default shall be declared for failure to make payment until 10 days after receipt of written notice

If the Amendment of Oil and Gas Lease referenced herein covers less than the entire undivided interest in the oil and gas or other rights in such land, then the dollar amount listed herein shall be paid to the Lessor (Payee) only in the proportion which the interest in said lands covered by the Agreement bears to the entire undivided interest therein. Further, should Lessor own more or less than the net interest defined here, Lessee (PDC) shall increase or reduce the dollar amount payable hereunder proportionately.

Lessor and Lessee agree that, when Lessor executed the Amendment of Oil and Gas Lease, Lessor and Lessee entered into a binding contract that, among other things, leases the lands listed in the Amendment of Oil and Gas Lease to Lessee. Lessee agrees to pay Lessor the bonus consideration for the Lease subject to Lessee verifying Lessor's net mineral acre ownership, as determined solely by Lessee.
