### AGENDA ITEM DESCRIPTION:

This item is a public hearing for the renewal application of BD Colorado dba Bad Daddy’s Burger Bar’s Hotel & Restaurant liquor license. Johnstown Municipal Code allows the Town Clerk to administratively approve a liquor license renewal unless the applicant is the subject of any official investigation or has had any adjudicated violations or stipulations within the preceding year.

BD Colorado dba Bad Daddy’s Burger Bar submitted a renewal application to the Town Clerk on January 29, 2024. During staff review, the Liquor Enforcement Division (LED) of the Department of Revenue provided the Johnstown Police Department with a report of a violation that occurred during a compliance check August 7, 2023.

The LED and Bad Daddy’s Burger Bar agreed upon a fine in lieu of a suspension, totaling \$897.15. The fine has been paid and the LED has closed the case. All other application materials have been reviewed and are found to be in compliance with State Statutes. Should Council direct the Town Clerk to renew the license, the application will be sent to the State licensing authority for consideration.
