AGENDA ITEM DESCRIPTION:

Enclosed for your review and consideration is an Intergovernmental Agreement (IGA) to approve the Highway 34 Access Control Plan. The Access Control Plan (ACP) for Highway 34 was adopted by the local government participants and CDOT sometime around 2003. At that time, the Town of Johnstown determined that it was not in its best interests to approve the ACP, and did not participate in the IGA. Looking forward, the Town's vision to help support and work collaboratively on regional projects and regional focuses, merit consideration and inclusion into the ACP and adopting the IGA. Accordingly, the plan is presented for your review and consideration. You will note the IGA presented has a date of 2003. Discussions with CDOT representative asked that they only be provided with the signature page if the Town Council adopts the IGA/ACP.

One of the obligations requested by CDOT, was to formally inquire with each of the existing participants of the Highway 34 Access Control Plan regarding any objections related to our inclusion into the ACP. A letter, which is attached, was sent to all participates on March 22, 2021. The letter formally asks for participants to object to our inclusion into the ACP; no responses were received. Considering no objections were received and the fact that we desire to
