### AGENDA ITEM DESCRIPTION:

The Town of Johnstown published the Downtown Johnstown Branding & Wayfinding Project Request for Proposal (RFP) on March 8, 2022. The RFP was available on the Town website and via the Town's Rocky Mountain BidNet account. Additionally, the Town held a virtual pre-bid meeting on March 21, 2022 to answer questions regarding the project and RFP from interested contractors/firms.

The Town closed the RFP on April 8, 2022 and received a total of 15 submissions. As a recap, the Downtown Johnstown Branding & Wayfinding Project RFP seeked proposals for the following professional services:

- Development of a brand identity for the downtown corridor
- Town wayfinding signage master plan
- Design and implementation plan of wayfinding signage in the downtown corridor
- Bid and fabricator support for the downtown wayfinding

The purpose of the project is to create a competitive identity for the downtown corridor through an engaging wayfinding system that increases vehicle and pedestrain traffic. Additionally, the Town master

The Town would like to award Michael Baker the Downtown Johnstown Branding & Wayfinding project as their proposal not only met the requirements of the RFP but provided a comprehensive outline of their engagement process to ensure community/stakeholder buy-in along with a proven record of creative placemaking and wayfinding for communities of similar demographics and size. Staff also reached out to the provided references and received positive feedback in terms of the quality work provided by the Project Manager Kristen Cypher. Johnstown is excited to bring this project to our community and begin engaging with our stakeholders to create a robust downtown identity and wayfinding that encourages vehicle and pedestrian traffic to our downtown corridor and ultimately contributes to the vibrancy and growth of the area.
