#### **AGENDA ITEM DESCRIPTION:**

The gas service lines in downtown Johnstown, currently managed by Xcel Energy, run along Parish Avenue. In 2023, Xcel reached out to the Town to propose replacing these lines to ensure compliance with updated regulations. To minimize disruption, especially for local businesses, the Town suggested relocating the gas lines to the alley west of Parish Avenue. This alternative avoids a six-week closure of Parish Avenue and provides several benefits, including reduced business interruptions and enhanced aesthetics by moving utility meters from the fronts to the backs of properties. Additionally, this relocation will enable the undergrounding of other existing aerial utilities to underground utilities to further improve aesthetics in the area.

In November 2023, the Town engaged BHA Design, Inc. for design and engineering services to support these service enhancements and aesthetic upgrades. With the electrical design phase now substantially complete, the Public Works Department (PWD) is seeking approval to commence Phase 1 of construction for the West Parish Alley Project. This initial phase focuses on relocating the electric utilities, beginning with Xcel Energy undergrounding their electric infrastructure in the alley. Once this work is completed, new surface-mounted transformers will be installed, followed by the installation of electric lines connecting the transformers to existing businesses.

To facilitate this phase, the Town issued a Request for Proposals (RFP) for the installation of electric lines from the transformers to the businesses. The Town received the following responses:

After evaluating the responses, the Town staff recommends awarding the contract to Morton Electric, the lowest bidder, whose proposal was comprehensive and met all requirements. Morton Electric has extensive experience with similar projects, provided positive references, and has a successful track record of working with the Town.

The Town plans to begin its portion of the project in August or September 2025, following Xcel's completion of undergrounding work. The Town's work is expected to conclude by the end of October 2025. To minimize disruptions, the Town has been working closely with business owners to secure easements and coordinate temporary outages, which are anticipated to last less than one working day per business. These conversations will continue to ensure minimal impact on stakeholders.

The funding for the West Parish Alley Project is included in the 2025 Fiscal Year Budget at a total amount of \$2,000,000.00.

**RECOMMENDED ACTION**: Staff recommends awarding the contract for the West Parish Alley Private Electrical Project to Morton Electric, Inc. in the amount of \$616,187.08.
