During this month we also reached the final planning stages of two major departmental projects. These programs are Citizens on Patrol and Women’s Self-Defense. A Citizens on Patrol Program draft has been submitted to the Joshua Citizen’s Police Academy Alumni Association (JCPAAA) for their input and suggestions. The next and final step would be discussion with City leadership about the final product and what that could look like. The first Women’s Self-Defense class is scheduled for November. The female members of the JCPAAA will be the first students in this initial, trial run. They provided donations to cover the cost of some of the materials used in this program so this will be a thank you and a shake-down run of our program at the same time.
