City Manager Peacock stated that there is an estimate of 1.5 million in the fund balance. In addition, he stated that the sales tax has flattened a little so we may fall short of the projections.

3. Discuss, consider, and possible action on the approval of the Economic Development Type B 2024-2025 Budget.

City Manager Peacock stated that only the day-to-day operations are in the budget, nothing else is funded since tax projection is low. In addition, he stated that no salary or cost of living increases are in the budget.

 - Park Manager Steven Gill gave the following update:
 - New benches installed
 - Fencing around the basketball court is installed
 - baseball fields are being worked on
 - The old playground has been removed
 - The concrete border has been removed
 - The proposals should be presented in October and the new equipment will be installed by summer.
 - Three bids will be presented on paper to the board and then the top will give a presentation in person.
 - Bin around dumpster at park installed
