# 3. Title 49 Rewrite Project Overview (presentation by Rob Dumouchel)

Special Project Planning Manager Rob Dumouchel provided a presentation introducing the Title 49 rewrite project and answered committee member questions. Mr. Dumouchel explained how the committee will fit into the process for creating, considering, and approving amendments to Title 49 which will have the following steps: 1. The committee provides guidance to project staff; 2. Staff creates the amendment and submits it to the Assembly; 3. The Assembly initiates a Title 49 text amendment and refers it to the Planning Commission; 4. The Planning Commission reviews the amendment and makes a recommendation; 5. The Assembly considers adoption; 6. If approved, the Community Development Department implements the changes.

4. Overview of initial Phase 1 text amendment proposals (presentation by Rob Dumouchel) Special Project Planning Manager Rob Dumouchel presented Title 49 text amendment concepts to the committee and answered questions from committee members. Concepts discussed included changes related to accessory dwelling units, caretaker units, uses not listed, determination of use (minor vs. major development), transition zones, adjustments to approved permits, and rules of construction. The discussion will be continued at the next meeting.
