03.10.040 - Parks and recreation department.



The parks and recreation department shall be responsible for:

- (1) The supervision and operation of recreation programs and for the maintenance and operation of parks and recreation facilities;
- (2) The maintenance and operation of Centennial Hall, **municipal parking lots**, the Youth Center, public cemeteries, and other facilities as assigned in writing by the manager;
- (3) Maintenance of all municipal buildings which are not the responsibility of another department or a board of directors.






