1. What about your life experiences and/or interests makes you want to be a Planning Commissioner?

 The intent of the Comprehensive Plan does not seem to be reflected in the Land Use Code. Updates to Comprehensive Plan and/or Land Use Code should be done in a way that brings the two into harmony with each other.
- 4. Do you have any interests that would pose a potential conflict of interest on matters coming before the Planning Commission?

I am an employee of the State of Alaska Department of Transportation & Public Facilities. I would have to recuse myself on certain matters if serving on the Planning Commission.

- 5. Describe your experiences in the areas of land use, construction, and/or transportation. I have extensive experience in land use planning including preparing zoning maps and utility master plans for small communities. Through working as a Professional Land Surveyor of many residential, commercial, municipal, state and federal construction projects I have developed great working knowledge of different types of construction practices and methods. Currently I am employed at Alaska DOT&PF and have experience in transportation projects including difference aspects as they pertain to obtaining funding for transportation related projects.
