Composting - Didn't receive the \$4 million SWIFR grant; it's very competitive. We are still using the congressionally directed spending from Murkowski (\$2.5m).

Update from Tlingit & Haida: they have a USDA grant for a 2-year project to reduce their organizational input to landfill. It's early stages but they are happy to share. They're housing an in-vessel composter at their building in the valley, which will take waste from all their facilities and potentially from other organizations in the future.
