Short Term

- 1) What percentage or estimate of Juneau residences don't currently have trash hauling service? Alternately, how many Juneau households do you provide with garbage service and how many do you provide with recycling service? (AK Waste)
- 2) Could there be other less expensive options besides weekly hauling service (i.e. every 2 weeks, monthly, etc.)? (AK Waste)
- 3) How can Juneau residents with trash hauling service get rid of items that don't fit in a trash can (i.e. furniture, tires, etc.)? Does your company have the labor available to handle a significant increase in requests for this service? (AK Waste)
- 4) Could the Saturday hours for residential drop off at the landfill be expanded? Are there any plans to further reduce residential drop off at the landfill or eliminate it completely? (WM)
- 5) What would it take to establish a transfer station that gives residents more opportunities to dispose of trash? Please speak to site needs, staff availability, and costs to residents and/or CBJ. (i.e. Maybe every Thursday evening at the high schools there are dumpsters available for a finite period of time) (AK Waste and WM)
- 6) What could a Trash Cleanup Day look like? Where could it be held? How would it be staffed? What's the max amount of waste that could be accepted at one time? What would it cost CBJ if it were free to residents? Etc. (AK Waste and WM)
- 7) Construction Debris How do you manage construction debris in the landfill? Are there any plans for the landfill to stop accepting construction debris? Based upon your presence in other communities, are there better or other options for construction debris versus disposing in the landfill? (WM)
- 8) Construction Debris Are there any solid waste regulations that prevent or promote the reuse of construction debris? (DEC)
- 9) What is the current fine for illegal dumping? How difficult is it to enforce illegal dumping rules? Can the fine be increased? (CBJ Law)

- 10) What facets of waste hauling and the landfill does RCA regulate? Could another entity (besides Alaska Waste) apply for a Certificate of Public Convenience and Necessity?(RCA)

- 18) PFAS Are there any plans to regulate PFAS in landfills in Alaska? Are you aware of any plans to regulate PFAS in landfills in the Pacific Northwest? (DEC)
