Re: CSM – Lot Combination - Dreamville Kaukauna

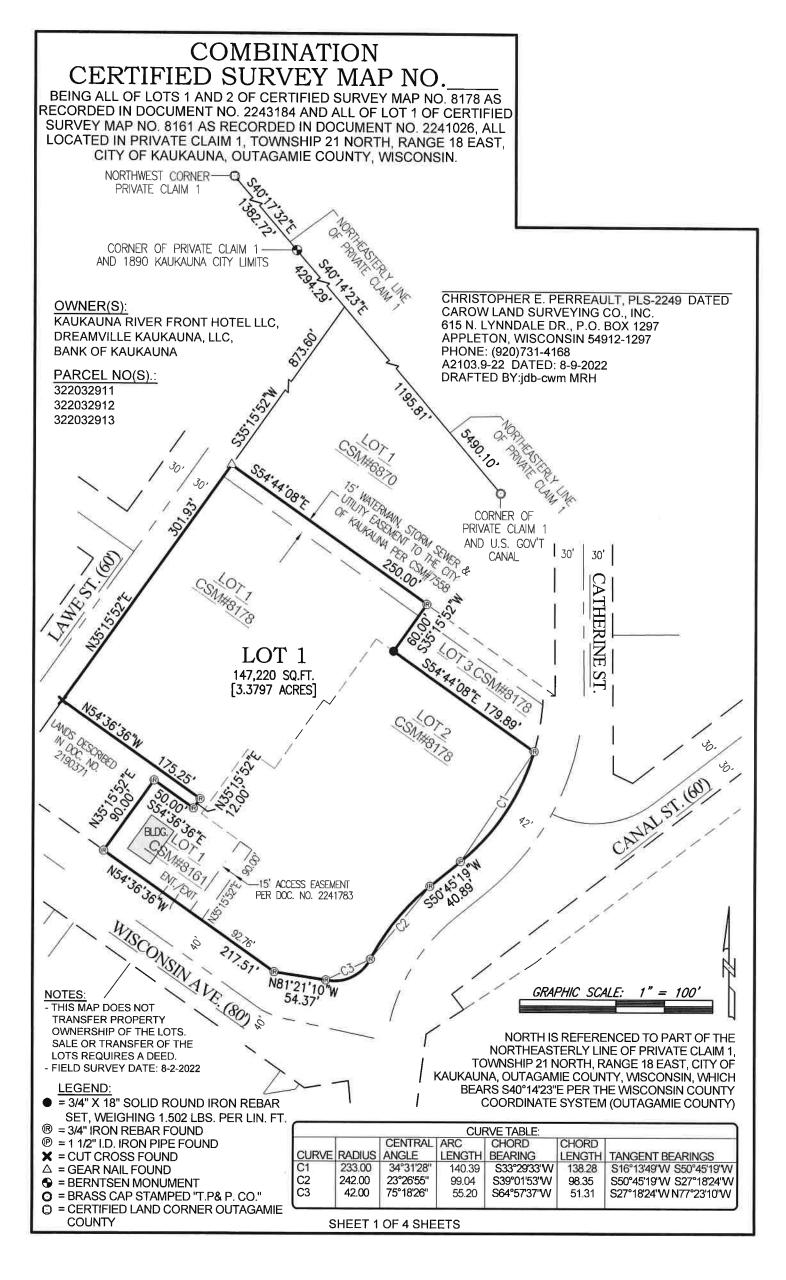
Dreamville Kaukauna LLC has submitted a certified survey map that will combine three parcels into one large parcel. Dreamville Kaukauna LLC is the owner of 222 Lawe, 250 Lawe, and 264 W Wisconsin. They are moving forward with the development of two apartment complexes and seek to have all parcels associated with that project under one common site.

The final parcel will be \sim 3.4 acres and meets all applicable zoning and subdivision requirements. The size, shape, and use of the lot conforms to city code.

Recommendation:

Approval of the Certified Survey Map for 222 Lawe Street, 250 Lawe Street and 264 W Wisconsin Ave and recommend the same to the Common Council with the following conditions:

- 1. The removal of 15' access easement located on 264 W Wisconsin Ave.
- 2. Prior to filing of CSM with Register of Deeds foundation work for the site has begun.
