 Endowment and to potentially oversee future large fundraising efforts. There was lots of
 discussion on the logistics of establishing the non-profit organization and board. Several
 questions were brought up. Nowak will follow-up with the Community Foundation, City
 Attorney Davidson and Finance Director VanRossum to gather answers to the questions
 and concerns. Another sub-committee meeting was tentatively scheduled for further
 discussion.
