SUBJECT: Award of Contract for the Kearney Boulevard Rehabilitation, Federal Project No. STPL-5291(030) to Emmett Valley Construction, Inc. (JJ)

RECOMMENDATION: Council by motion adopt the resolution awarding the contract for the Kearney Boulevard Rehabilitation, Federal Project No. STPL-5291(030) to Emmett Valley Construction, Inc. in the amount of \$351,738.00 and authorize the City Manager to sign the contract.

EXECUTIVE SUMMARY:

The Kearney Boulevard Rehabilitation, Federal Project No. STPL-5291(030), will consist of the rehabilitation of the existing pavement on Kearney Boulevard from Park Avenue to Del Norte Avenue. Portions of the street with more significant deterioration will be dug out and reconstructed and then the entire street will receive an asphalt overlay to provide a smooth driving surface. The Project will also include the replacement of various concrete improvements where they are currently damaged or non-compliant with ADA accessibility guidelines. The Project was advertised and bids were received from eleven contractors on Wednesday, March 8, 2022, and the results are as follows:

Staff has reviewed the bid submitted by Emmett Valley Construction, Inc., along with information regarding their previous work experience. Based on review, Staff has determined the bid received to be responsive and Emmett Valley Construction, Inc. to be a responsible contractor.

FISCAL IMPACT:

The total estimated Project cost is \$490,000, including design, construction, construction management, and contingency. The Project will be funded with \$382,523 in Federal Surface Transportation Block Grant (STBG) funds and \$107,477 from Local Transportation Funds. There are sufficient Local Transportation Funds budgeted in the FY 22/23 Budget for the Project.

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KERMAN
AWARDING CONTRACT FOR THE KEARNEY BOULEVARD REHABILITATION,
FEDERAL PROJECT NO. STPL-5291(030), TO EMMETT VALLEY CONSTRUCTION, INC.**

WHEREAS, the Invitation to Bid for the Kearney Boulevard Rehabilitation, Federal Project No. STPL-5291(030), was published in the Kerman News on February 1, 2023 and was sent electronically and mailed to all construction trade journals specified for the City by the California Uniform Construction Cost Accounting Commission in accordance with the City's Formal Contract Procedures and California Public Contract Code Section 22037 and;

WHEREAS, the Project consists of the rehabilitation of the existing pavement on Kearney Boulevard from Park Avenue to Del Norte Avenue, within the City of Kerman; and

WHEREAS, the following bids for the Project were publicly opened and read aloud at the Kerman City Hall on March 8, 2022 at 2:00 p.m.:
